2. What are the rules?

3. Key Rules

- Entry will be free.
- The Inter school debate being organized in connection with MED-ATHLON 2024 is for the teachers only.
- Each School can send a team of three teachers
- Entries should contain the names of the participants and the name of the school.
- There should also be the details of one contact person who can be reached by the organizers.

- The last date for receipt of entries is **Thursday 21 November 2024**

- Topics for the preliminary rounds and the finals will be different. There will be a preliminary selection round to shortlist the two finalists
- Preliminary rounds will be held on **26 November & 27 November 2024**. depending on number of participants (timings will be intimated).
- Finals will be on **29 November 2024** (timings will be intimated)
- The Organizing Committee reserves the right to accept or reject any application and is not obliged to give any explanations.
- The topics will be given to the teams well in advance. However which team speaks “For the Motion” and which team will speak “Against the Motion.” will be decided just prior to the competition and by draw of lots.
- Each member of the team will be given three minutes to speak.
- After all team members have spoken, the Team leaders peaking against the motion will give his/her concluding remarks followed by the Team leader speaking for the motion (3 minutes)

4. Judging criteria

Debates will be judged on the following criteria:

- Marks will be given to the team member’s ability to challenge the point put forth by the previous speaker and to bring in a new point.

- The team which challenges and brings in points to support their stance with conviction will be declared the best team.
- Content, Style of delivery, voice modulation will also be counted in deciding the best team.

5. Debate competition and prizes T&Cs

- Contestants shall strictly adhere to the relevant rules and regulations laid down by AMH organizing committee.
- The Organizing committee reserves the right to cancel the event or alter the programme schedule without assigning any reasons.

- The Organizing Committee reserves the right to accept or reject any application and is not obliged to give any explanations.
- All films must be original creation and will go through an initial screening. There will be a preliminary selection round to shortlist the five finalists.

- The theme of the Short film competition is

“Healthcare & Healing - Today & Tomorrow”

- **FORMAT:** The films may be shot in MPEG4 or AVI format. The recommended ratios are: 16:9 / 16:9 Full Height Anamorphic - in DV/HDV.
- The film may be submitted by providing the committee a link on a free file hosting service e.g. Drop box or Google drive
- Theme and/or visuals of the films should not be against the Laws of the Kingdom of Bahrain or against the Bahraini society. Such films will be withdrawn without any prior notice.
- The length of the film must not exceed 3 minutes (including the titles).
- The script should be an original work of the school filmed in Bahrain.
- Films already broadcast via YouTube, any other internet forums or social media will not be entertained.
- Films not in English must have English sub-titles.
- Incomplete films, with production or post-production works pending, will not be accepted. (Organizing committee will use the films submitted along with the application for initial screening)
- Organizing committee retains the right to change, modify or freeze the date of the film contest and screening.
- Decision of the judges will be final regarding the films shown in the Competition section.
- Entries must adhere to the THEME regarding appropriateness of content. Entries that are in violation of local laws or otherwise deemed by the organizers in its sole discretion, to be inappropriate will be disqualified.
- Entries determined to infringe on any intellectual property rights or other rights, will also be disqualified at the sole discretion of the organizers.

- The entry may not include confidential information, trade secrets, trademarks or copyrighted material belonging to any person or entity other than the Participant.
- Participants are responsible for securing necessary permissions, talent and location releases, and licenses for visual and audio material contained in the submissions.
- Participants may only use original music/images/graphics created for the film, music/images/graphics that are in the public domain, or music/images/graphics that the filmmaker has appropriate permissions to. Usage of Royalty free music and audio tracks are recommended.
- Organizer is not responsible for any expenses incurred in the production and delivery of the film entries.
- Any entry that does not comply with the above restrictions or any other requirement herein is subject to disqualification.
- Participating in the Short Film competition constitutes Participant/s full and unconditional agreement to and acceptance of these Official Rules.
- Any disputes arising from or relating to the contest or the selection of winning submissions will be resolved at the sole discretion of the Organizing Committee. A short synopsis of your film must be included.

- Content or Contemporary relevance
- Originality
- Technical Excellence
- Overall Quality

- **Value:** 20 marks (Idea, Logic, Original thought)
- **Overall Impression:** 10 marks
